

**REGULATIONS CONCERNING STAYING IN THE "GREEN RIVER" AREA  
and the GENERAL NATIONAL EXHIBITION SQUARE**

1. The generally accessible parts of the MTP grounds, i.e. the General National Exhibition Square and the so-called "Green River" (hereinafter jointly referred to as the "Green River") shall remain open to visitors on each day of the week **from 6 am to 11 pm**. The opening hours of the catering outlets located at the Green River area are determined by operators of these outlets are defined separately.
2. MTP reserves the right to change the opening hours of the "Green River" depending on events planned or organised on the MTP grounds.
3. Staying in the "Green River" area may be subject to restrictions imposed by law, event regulations as well as those arising from the MTP decisions.
4. Every person staying in the "Green River" area **is obliged** to:
  - 1) remove all waste generated by them and discharge it to containers deployed in designated places, labelled in accordance with the rule of selective waste collection,
  - 2) comply with any organisational instructions issued by MTP services, Fire Brigade officials or other state services, in particular during evacuation, rescue operations, control and investigation activities.
  - 3) comply with the principles of these Regulations. Only persons who comply with the rules set out in these Regulations are authorised to use the "Green River" and to stay there.
5. Within the "Green River" area it is **prohibited** to:
  - 1) stay outside the applicable opening hours,
  - 2) bring in dangerous devices and objects such as weapons, ammunition, pyrotechnical materials; in the event of suspected carrying in of the above-mentioned objects, MTP security has the right to ask for the presentation of the objects brought in to the Green River; the refusal to accept the presentation of the objects may result in the necessity to leave the MTP grounds immediately,
  - 3) carry and consume alcoholic beverages, with the exception of the consumption of alcoholic beverages purchased or served in places clearly designated for this purpose, including the area of catering outlets and other commercial spaces
  - 4) smoke tobacco products, except in specially marked and designated areas,
  - 5) contaminate the space with any kind of waste,
  - 6) light or use open fire,
  - 7) interfere in any way or damage elements of the infrastructure of the space, including vegetation, and to use this infrastructure in a manner incompatible with its intended use,
  - 8) distribute publicity materials, carry out electoral and social campaigns, organise collections without the MTP consent,
  - 9) carry out any form of business activity without the consent of MTP expressed by e-mail,
  - 10) record for commercial purposes using multimedia equipment the course of events taking place in the "Green River" area without the consent of MTP,
  - 11) leave luggage or other items (belongings) brought into the "Green River" area unattended, as well as abandoning brought items (things),
  - 12) enter and move by cars, motorbikes, quads, scooters and other similar vehicles,

- 13) feed wildlife and scatter food,
  - 14) enter and bathe in fountains and other water reservoirs and installations,
  - 15) consume circulating water, including, in particular, in fountains and other water reservoirs and installations,
  - 16) ride bicycles, scooters, etc. off designated paths in a manner that poses threat to property or the health or life of individuals.
6. Pets are allowed in the "Green River" area, provided that they are kept on a lead and, in the case of a dog breed considered aggressive, also muzzled. A person bringing in an animal is obliged to clean up any waste left behind by the animal.
  7. In the event of non-compliance with the restrictions, orders or prohibitions set out in the Regulations, the offending person may be immediately removed from the MTP grounds. In justified cases, MTP may call (notify) the relevant services, including the police.
  8. The Regulations shall enter into force as of 1<sup>st</sup> of December 2023
  9. Green River area map is an annex to the regulations.
